The following rules of qualifications have been prescribed by the Academic Council at its meeting held on 09.03.2002 for the post of Lecturers in the Arts and Science College as per the UGC Guidelines along with the amendment notification of 2006 :

“Good academic records with atleast 55% of the marks or an equivalent grade of B in the seven point scale with letter grades O,A,B,C,D,E & F at the Master’s degree level, in the relevant subject from an Indian University or an equivalent degree from a foreign University.

Besides fulfilling the above qualifications, candidates should have cleared the eligibility test (NET) for Lecturers conducted by the UGC, CSIR or similar test accredited by the UGC.

NOTE :

1) NET shall remain the compulsory requirement for appointment as Lecturer for those with Post-graduate degree. However, the candidates having Ph.D. degree in the concerned subject are exempted from NET for PG level and UG level teaching. The candidates having M.Phil. degree in the concerned subject are exempted from NET for UG level teaching only.

2) A relaxation of 5% may be provided from 55% to 50% of the marks at the Master's Level for the SC/ST categories, physically handicapped and Visually challenged persons."
