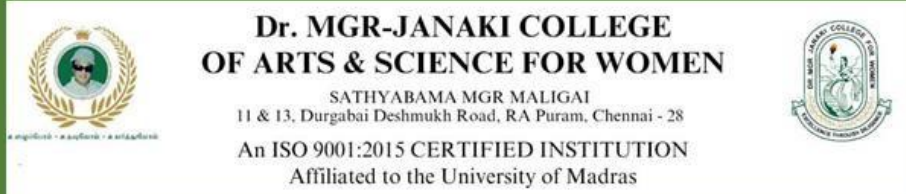

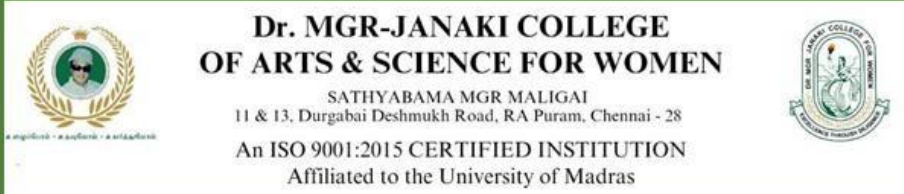

- Other forms of co-operation made by mutual agreements hereafter.



Head of Department of Psychology and student coordinator, have to be introduced while signing the MoU.


The HOD should verify periodically (Once in two months) about the goodness of interaction and also the support needed.
